2016 EHF "Rinck" Convention (RC) Open Master Coach and Licensing Course**

Dear Handball Friends,

In our efforts to develop women's handball in Europe, the EHF Women's Handball Board (WHB) are very interested in initiating opportunities for women involved in handball, in order to expand their knowledge and expertise, and to increase the number of competent women in key positions; our ultimate aim being to support and strengthen women's handball and to promote female leadership.

Another main objective is to recruit and encourage current elite female players to remain in handball after the end of their playing career, through tailored educational opportunities, aimed at enhancing their skills in roles such as coaches, delegates, referees, and sports managers. These role models would inspire the future generations of handball players, to take up and remain within our sport through the career pathways created.

Therefore, upon the initiative of the WHB, the European Handball Federation will invite

- **5 female coaches** to take part in the **2016 EHF Top Coaches' and EHF License Renewal Seminar** (Krakow, Poland from 14-17 January 2016)
- **3 female coaches** to take part in the **2016 EHF "Rinck" Convention (RC) Open Master Coach and Licensing Course** (Module1/Krakow, Poland 14-21 January 2016). The respective course will be organized in three (3) modules.

and support them by covering their course fees. Please note that the candidates will be selected by the WHB according to the selection criteria and/or on a "first come – first served" basis.

SELECTION CRITERIA:


- Max. 1 candidate endorsed by a Member Federation
- Female coach holding a national coaching license (Level 3 RC) / to apply for the Master Coach Course only
- Registration by the respective National Federation
- A current CV highlighting achievements in handball
- Extensive knowledge of oral and written English
- Availability and agreement to undertake promotional activities and related interviews as well as contribution of personal stories and involvement in EHF activities.

The National Federation is requested to submit the copy of registration for the applicant together with the current CV and a copy of applicant's respective national coaching license to cuderman@eurohandball.com not later than 30 November 2015. Successful applicants will be advised in due course.
